This information is intended for those who apply for participation in the Jema Award – Looking for purity.

The information is given pursuant to art. 13 and 14 of Regulation (EU) 2016/679 (GDPR).

We inform you that **Gerardo Cesari S.p.a.** will proceed to the processing of personal data present in the request for participation or possibly communicated with supplementary documents of the request by the candidates.

The legal basis of the treatment is based on Article 6 paragraph 1 letter "e" and in articles 9 and 10 of the GDPR.

### **SUBJECTS OF TREATMENT**

### **PURPOSE AND METHOD OF TREATMENT**

The supplied data are processed for the management of the selection procedure and for the communications relating to the results.

The personal data of the candidates are processed by the members of the selection committee/jury, by the offices in charge of the communication procedures and by those responsible for the formalization and organization of the Award's final event.

It's specified that data are processed with or without the aid of electronic tools; in the latter case, the IT systems are equipped, in accordance with the provisions of Chapter IV of Regulation (EU) 2016/679, of security measures to prevent data loss, illicit or incorrect use and unauthorized access (for example profiling of access rights to databases).

The management of paper-based data (for example the management of participation requests) provides specific organizational security measures (for example keeping key applications, archiving them in the archives, not disclosing information).

### **DATA CONSERVATION PERIOD**

The data will be stored:

as regards the personal data contained in the requests for participation, or in the documents attached, the retention times are defined by the timing of the award rules.

With regard to the personal data included in the information systems, please refer to the principles set out in art. 5 EU regulation 2016/679, for a period of time not exceeding the achievement of the objectives and with specific regard to the principle of limitation of conservation pursuant to art. 5, lett. "E" of the EU 2016/679 regulation.

#### **NATURE OF DATA SUPPLY**

The provision of data is necessary for the achievement of the purposes indicated above. In the absence of such data candidates will not be admitted to the selection.

#### **LEGAL BASIS OF TREATMENT**

Personal data are processed in accordance with articles 6 paragraph 1, 9 and 10 of the GDPR.

#### **RIGHTS OF THE INTERESTED PARTY**

The subject to whom the personal data refer has the rights set out in sections 2, 3 and 4 of Chapter III of Regulation (EU) 2016/679.

In particular, you have the right to ask the Data Controller: access and correction to personal data, cancellation of the same, limitation of processing that concern them, opposition to their processing and to data portability.

It also has the right to lodge a complaint with a supervisory authority.

These rights can be exercised by writing to the Data Processor.
